1. Welcome and apologies.

AG chaired the meeting and accepted apologies from GA/PA & DW.

2. Equipment usage and petrol money (Petty Cash).

BH collected £3 from MD for use of the shredder.

3. Battery tools.

BH reminded attendees that there is a spare spool for the battery strimmer in the Container on the wall by it, and that whoever uses it, please tell him to replace it.

4. Bees.

The Beekeeper, Ade Morris, had a disastrous winter, losing 13 over-wintering colonies leaving him with only 4. Usually he loses one or two, but this loss is unprecedented. There's plenty of stored pollen over winter but no bees or eggs, and DEFRA are as dumbfounded as he is. So he is going to burn all the frames, sterilise all the boxes and start afresh hoping that he can increase the hives from his surviving colonies. The upshot is that it's going to take a year or two before he is near to getting the number of colonies back to full strength.

5. Wildflowers & mare's tail.

- **a.** DJ plans to sowing clover seeds when the weather warms up, combining them with grass seed which has proven to be a good barrier against the more invasive weed varieties. He will start with the patch outside the Container doors.
- **b.** BH said that if DJ's trial is successful, he would provide funding for more seeds.

6. Cherry blossom tree overhanging plots 5 & 6.

Previous minutes refer. Having contacted CCBC, United Welsh & Celtic Horizons and being passed from pillar to post, MR has understandably come to the end of his tether. After a lengthy discussion the following was agreed.

- **a.** IT mentioned that we are unlikely to get anything done as the United Welsh residents will be liable to pay for any tree surgery.
- **b.** MD & MR offered to look at cutting down the overhanging branches, ensuring they undertake relevant risk assessments and adhere to HSE guidelines!

7. Grants.

For information: MD previously mentioned that Monmouthshire Building Society were offering grants, saying that Fernlea had taken advantage of their offer. It was agreed that this gives us another option when we require funding in the future.
